TERMS & CONDITIONS

Period of engagement shall initially be for six months which can be extended by mutual agreement. The arrangement is purely temporary without any claim of regular employment/permanent absorption. 4. JKSPDC Shall not be a party to the dispute arises out of any medical negligence/lapse occurring during the treatment rendered by the Physiotherapist.

5. The Physiotherapist shall not solicit or accept any gift from employees.

6. The Physiotherapist shall not solicit or accept any gift, commission or bonus in consideration of or return for the referring or recommending JKSPDC beneficiaries for the treatment to outside medical agencies.

7. The Physiotherapist shall not outsource his services.

8. Physiotherapist shall abide by any law relating to intoxicating drugs and drinks enforced in the area.

9. The Physiotherapist shall strictly abide by the rules / instructions issued by JKSPDC from time to time.
