Applications on format prescribed at Annexure 'A' to this Notification, are invited from eligible candidates from permanent residents of J&K, conforming to the following eligibility standards for temporary engagement for the position of Junior Project Fellow in the project mode for the research Project, "Survey and census of wildlife to establish base line information in Overa Aru Wildlife sanctuary in J&K" for a period of 03 months on the terms @ conditions indicated in this notification.

TERMS AND CONDITIONS:

1. The position is temporary and the selected candidate shall not have any claim on absorption in the Department.
2. The selection shall be co-terminus with the project.
3. The selectee shall have to work in wildlife areas on foot and shall be required to travel/stay in remote wildlife areas for conducting field surveys.
